- A. President- WGI Advisory Board changes to be reflected in the handbook: Percussion- No ensemble can compete with less than 5 performers, soundboards/audio electronics can be operated wirelessly, winds timing limits have gone down. Casey Noel will be appointed as Treasurer following Michael Clark's resignation.
- B. Vice President Nothing new to report.
- C. Treasurer All outstanding accounts receivables have been collected, all checks have been cashed, all scholarships have been paid. We are in good standing to start the next season. Savings: Checking: Puts us in a good position to absorb Competition Suite and Travel Expenses

- E. Judges' Coordinator- Things are going well, I am sending out updates to our judges following the WGI Advisory Board and the new WGPO manual to judges.
- F. Percussion Coordinator- We had two WGPO Percussion groups attend world championships! Artistry judges sheet will now be called Effect and you will see more unity. Staff can now control specifics through Main Stage wirelessly. They still can not trigger anything but can make adjustments as needed.
- G. Director of Education All team Oklahoma that participated in WGI Worlds were finalists! Jara is stepping down as Director of Education.
- H. Contest Director- We have two bids for State so far, Yukon and Union. We are extending the deadline for Championships bids so
