- A. President: Nothing new to report
- B. Vice President: We had a very successful season for scholarships and were able to give out more than anticipated. All funds have been dispersed.
- C. Treasurer: Total income this year: \$117,921.11, Expenses: \$97,035.23, Currently have \$34,665.90 in the checking and \$35,244.96 in the savings account. All accounts have been settled and books are closed for the season.

- E. Judges' Coordinator: Not in attendance.
- F. Percussion Coordinator: We had a very successful season with several OK groups competing at World's. Judging panels are underway.
- G. Director of Education: We had a great year, with 3 different trainings. Hoping to plan an in person spin clinic, perhaps in conjunction with the fall meeting.
